SECTION 4: First aid measures

4.1 Description of first aid measures

General information

In all cases of doubt, or when symptoms persist, seek medical advice. If unconscious but breathing normally, place in recovery position and seek medical advice.

Following inhalation

Remove casualty to fresh air and keep warm and at rest. In case of irregular breathing or respiratory arrest provide artificial respiration.

Following skin contact

Remove contaminated, saturated clothing immediately. After contact with skin, wash immediately with plenty of water and soap. Do not use solvents or thinners. Wash contaminated clothing before reuse.

After eye contact

5.2 Special hazards arising from the substance or mixture

Dense black smoke occurs during fire. Inhaling hazardous decomposing products can cause serious health damage.

7.1 Precautions for safe handling

Requirements for storage rooms and vessels

Storage in accordance with the Ordinance on Industrial Safety and Health (BetrSiVO). Keep container tightly closed. Do not empty containers with pressure - no pressure vessel! Smoking is forbidden. Access only for authorised persons. Store carefully closed containers upright to prevent any leaks. 8.2 Exposure controls

Practical experience/human evidence
